PRO HD RENTALS, INC. WILL RENT TO YOU FOR AN EXTRA FEE...RENT EQUIPMENT WITH **NO INSURANCE** FOR EQUIPMENT RENTALS VALUED UP TO \$30,000.00
(Some restrictions apply, read below).

GENERAL LIABILITY WAIVER FOR PRO HD RENTALS, INC.

(You must purchase this waiver if you do not supply Pro HD Rentals, Inc. with a general liability certificate of insurance naming Pro HD Rentals, Inc. as "Additionally insured")

COST: 10% of total rental cost.

WHAT **IS** INCLUDED IN COVERAGE:

- Pro HD Rentals, Inc. will buy from its own insurance carrier additional general liability coverage, so that Pro HD Rentals, Inc. will be covered for general liability on equipment rentals when the equipment has left the premises.

WHAT IS **NOT** INCLUDED IN COVERAGE:

- You are **NOT** buying general liability insurance from Pro HD Rentals, Inc. Pro HD Rentals, Inc. is buying additional liability insurance coverage on their own policy for coverage or Pro HD Rentals, Inc. **only**. (If there was a lawsuit or an accident, Pro HD Rentals Inc.'s insurance carrier would represent Pro HD Rentals, Inc. only, and nobody else.)

WHAT **IS** NEEDED TO BE COVERED:

- **Pay 10% of total equipment rental before rental.**

DAMAGED EQUIPMENT COVERAGE:

(You must purchase this coverage unless you supply Pro HD Rentals, Inc. with an equipment insurance certificate for no less than the full replacement value naming Pro HD Rentals, Inc. as "Loss Payee" of give Pro HD Rentals, Inc. a CREDIT CARD pre-authorization for no less than the full replacement value. Optional damaged equipment coverage is only available for up to \$30,000.00 insurance value.)

COST: 10% of total rental.

WHAT **IS** INCLUDED IN COVERAGE:

- Pro HD Rentals, Inc. will pay for repair or replacement of damaged lighting equipment, grip equipment, camera accessories, broken or damaged light bulbs rented from Pro HD Rentals, Inc., over the \$2,000.00 deductible.

WHAT IS **NOT** INCLUDED IN COVERAGE:

- You will pay fro the first \$2,000.00 of damage(s). It will be Pro HD Rentals, Inc.'s sole discretion in **determining the cost** of repair.
Missing, lost, stolen, unaccounted items. You will pay full **replacement value** of any missing items. Missing items are **not applied** to the damage deductible.

WHAT **IS** NEEDED TO BE COVERED:

- Cash deposit (NO CHECKS) or Credit Card pre-authorization of \$2,000.00.
 - **Pay 10% of total equipment rental before rental.**

BURNED OUT LIGHT BULBS COVERAGE:

(You must pay for burned out light bulbs unless you accept this coverage)

COST: 10% of total lighting rental cost.

WHAT **IS** INCLUDED IN COVERAGE:

- Incandescent, fluorescent, HMI light bulbs. If a light bulb burns out naturally, you will not be **charged** for it.

WHAT IS **NOT** INCLUDED IN COVERAGE:

- Missing, lost, stolen light bulbs (If you have a burned out light bulb YOU must return it or you will be charged)
Light bulbs that have been damaged by operator error, dropped, broken, improperly installed, improperly cleaned, touched, pitted by dust, fluorescent light bulbs with broken pins. It will be Pro HD Rentals, Inc.'s sole discretion in determining whether a light bulb is burned out or damaged. Damaged light bulbs will be covered only if you purchase the optional "Damaged Equipment Coverage", see below.

WHAT **IS** NEEDED TO BE COVERED:

- **Pay 10% of total lighting rental before rental.**
